### OIL REPORTED IN YELL COUNTY TEST

### Showing in Test by Greeks' Syndicate Creates Excitement.

Gravelly, Oct. 3.—The barrel or two of oil which has been baled from the No. 1 well of the Gravelly Petroleum Company, near here, has created much excitement in this section of Yell county. Work at the test has been suspended until arrival of officials from New York when it is expected the well will be deepened about 300 feet.

Showing of oil is the result of about

three months' efforts by Simon Simonedes of Pine Bluff and several other Greeks, who formed a company backed by New York capital, and blocked off 20,000 acres.

Drilling with a standard rig has progressed and created but little interest. due to similar tests made in this section several years ago. But when an oil showing was reported yesterday, persons for many miles around began llocking to the well, taking samples of the oil and talking of oil possibilities.

Mr. Simonedes, who was interested in the development of oil in Oklahoma

several years ago, and in charge of the drilling here, although pleased with the showing, does not appear excited. He says that it will be several days, and perhaps weeks, before the real oil can be reached. The company has planned to make a real test of possi-bilities in the section and will drill, if necessary, to a depth of 2,500 feet, he

The test is within five miles of the The test is within five miles of the two wells drilled five or six years ago, which first were reported as high gravity wells, only to be water wells with a small percentage of oil.
